**1. DUES AND FEE STRUCTURE**

By January 1<sup>st</sup> of each year, all Associate Golf members will be required to pay their annual dues. The cost will be \$1200.00 + tax per single and \$1600.00 + tax per family.

**2. APPROVAL OF MEMBERSHIP**

I understand that acceptance for Westminster Golf Club, is subject to approval by the Board of Directors of the Westminster Golf Club. Upon approval I will be responsible for payment of all fees. Failure to pay fees will result in my expulsion from Westminster Golf Club without refund.

**GENERAL INFORMATION FOR ASSOCIATE GOLF MEMBERSHIP:**

- Access to the clubhouse and its facilities at Westminster Golf Club
- A Ten percent (10%) discounts on all regularly priced merchandise in the golf shop.
- Fees will be \$20.00 less than whatever current Public Rates are on daily Green & Cart Fees +Tax. Fees will be a minimum of \$35.00. (Example: Public Fees are \$65.00, your fee will be \$45.00 and if Public rates are \$40.00 your rate will be \$35.00). Westminster Events are the exception no \$20.00 reduction in fees will apply however, if public rate is lower than \$35.00 the lower rate will also apply.
- The opportunity to obtain tee times four (7) days in advance.
- Charging privileges in the Pro-Shop and the Restaurant. Monthly statement will be provided.
- All outside tournaments and events will take priority over the tee sheet and these days restrict tee time availability.

- If you have a private cart there is no reduction in fees for using you own cart.
- **NO** discounts for Member Guest, **ONLY RELATED GUEST.**
