



APPLICATION FOR RESIDENT AND NON-RESIDENT MEMBERSHIP 2012

1. **INITIATION FEE STRUCTURE**

The undersigned hereby applies for a Resident/Non-Resident Membership at Westminster Golf Club, and agrees to pay the Club an initiation fee in the amount of \$7,000.00 + 6% sales tax for a **Single** (This fee can be paid in two payments of \$3500.00 +tax over a two year period)

The undersigned hereby applies for a Resident/Non-Resident Membership at Westminster Golf Club, and agrees to pay the Club an initiation fee in the amount of \$10,000.00 + 6% sales tax for a **Family**. (This fee can be paid in two payments of \$5000.00 +tax over a two year period).

2. **ANNUAL FEE STRUCTURE**

On January 1st of each year, all Resident and Non Resident Golf Fees are required to be paid annually. The cost for 2012 will be \$3900.00 + tax for a single and \$4400.00 + tax for a family. Members with their own golf cart shall pay a "**Reduced Cart Fee**" of \$21.00+ tax and use of fleet carts shall be \$26.00 + tax per member each time you play.

3. **APPROVAL OF FEES**

I understand that acceptance for Westminster Golf Club, is subject to approval by the General Manager of the Westminster Golf Club. Upon approval I will be responsible for payment of all fees. Failure to pay fees will result in my expulsion from the Westminster Golf Club without refund.

GENERAL INFORMATION FOR RESIDENT & NON RESIDENT GOLF FEES

- Golf members may obtain tee times four (4) days in advance.
- On the third (3) day prior to play, all remaining tee times will be opened to the public.
- Members shall have charging privileges throughout the club (pro shop, restaurant, golf etc.) and will be billed monthly.
- Golf members will receive a 10% discount on all regular priced merchandise in the golf shop.
- Range Balls will be ½ Price for members use only.
- Resident golf members who elect to rent their property at Westminster may transfer their Resident Membership to renters for a reasonable administration fee payable to Westminster Golf Club. Should the member elect to play during the period the renter is authorized to play on the members account, the golf member will be charged regular green and cart fees and access to tee times will be limited to 3 days in advance notice (see Transfer of Membership).
- In the event of outside tournaments or other outside golf events, the 4 day advanced tee times shall not apply.
- Members have first priority in enrolling in all tournaments and golf events sponsored by Westminster Golf Club.
- Resident Golf Member's children under nineteen years of age, (Living at home) are entitled to the same privileges as their parents.

- Birthday Discounts
- **NO** discounts for member guest, **ONLY RELATED GUEST.**
- **Related Guest of members are defined as:** Son, Daughter, Mother (in law), Father (in law), Grandmother, Grandfather, Brother (in law), Sister (in law), Son (in law), Daughter (in law), Grandson, Granddaughter. When playing with a member.
